On behalf of the managing committee of IMA's Karnataka State health scheme and myself, as the chairman, I extend my warm welcome you all to the annual general body meeting.

I am Happy to inform you all, that we the new managing committee members under my leadership completed second year successfully.

We introduced the health scheme in our state, in association with IMA Karnataka state branch on 5thSeptember 2016 under the leadership of Dr. Chinivalar during the presidentship of Dr.G.N.Prabhakar.

As you all know it's the vision of Dr. Yogananda Reddy, Dr. Honnegouda, Dr. Madhusudhan Kariganur, who guided since the beginning to till today during these 7 years, periods all the presidents of IMA KSB, Dr. R.S. Bellary, Dr. H.N. Ravindra, Dr, Annadani Meti, Dr. Madhusudhan Kariganur, Dr. Venkatachalapaty, Dr. Suresh Kudva, Dr.S.B. Lakkol and Dr. Srinivasa S have helped and guided a lot to increase the membership growth during their terms, Dr. V. V. Chinivalar has personally visited all branches of IMA Karnataka State and brought the Active strength to 987. This year we have enrolled more than 39 new members, as of now no dues from all the enrolled members.

To compare the strength, in IMA Kerala state branch, that it has crossed 20 thousand primary and associate members and their upper limit of reimbursement has gone up from 2 lakhs to 3 lakhs, its only possible if our membership strength increases. 
