MINUTES OF THE 2ND GENERAL BODY MEETING OF IMA-KSHS

HELD ON 27TH OCT-2017-GADAG.

Secretary Dr.Sharanabasava Sankanur requested the chairman to conduct the meeting. Secretary Dr.Sharanabasava Sankanur read the IMA prayer & meeting notice

Chairman Dr,Chiniwalar welcomed the Office bearers of IMA KSB,KSHS and members of KSHS. He briefed regarding the progress and present status of Health scheme, Launching of the Scheme by Dr.ALEX FRANKLIN, Secretary National Health Scheme on 1st July 2017 –DOCTORS DAY. Since then 4 claims have been reimbursed to our KSHS members. Chairman informed the house about the following members inability to attend the meeting, Dr.P.Vijaya Venkatesh,Dr.B.Mahaliga,Dr.SarveshRaje Urs and Dr.H K Nagesh and ratified the previous managing committee report regarding Founder membership till it reaches 500.

Chairman informed the house regarding the present strength of KSHS and requested the members to motivate other IMA members.The following 4 IMA KSHS Members have received the claims. 1.Dr.Mahabaleswar Reddy of Hosapete, 2.Dr.Pampapathi Malagi of Gangavathi 3.Dr.B.Ramadas of Hosapete and Dr.Shivaganga of Gangavathi as per the recommendation of scrutinizing committee headed by Dr.K T Prakash Reddy. Secretary read the report of regarding the membership strength district wise. He requested the august body and IMA office bearers to make IMA KSHS membership compulsory for the IMA KSB office bearers as that of KPPS & KSSS.

Dr.Madhusudhan K Treasurer presented the audited report of accounts from 05-9-2016 to 31-03-17.

Many members took part in the discussion and suggested for the increase of membership. Dr.B M Alur suggested to visit every branch along with President KSB and inform the members the benefit of the scheme. Dr.S T Yavagal suggested every member should enroll and motivate others. Dr.YoganadaReddy and Dr.PV Kanchi suggested fractional initial premium for those who enroll in the middle of term of financial year. This has to be discussed in detail in the managing committee. Members suggested to give printed annual report .

District wise Co-Ordinators to be nominated to increase and smoothening of the function of IMA KSHS in scrutinizing the claims.

To discuss with Auditor regarding INCOME TAX benefit under 80 D-non taxable/rebate.

Discussed to introduce no claim bonus to non claimers but not finalized as the premium amount is low compared to National and Kerala Health Scheme. Dr.H N Ravindra suggested to study and get clarification from Insurance companies.
